Description

This 2½-day comprehensive review course and hands-on cadaver workshop will describe and demonstrate improved skill levels of vertebroplasty, kyphoplasty and sacroplasty. 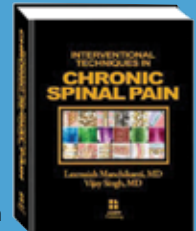
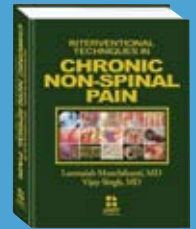
